A RESOLUTION APPROPRIATING ADDITIONAL SUMS OF MONEY TO DEFRAY EXPENSES IN EXCESS OF AMOUNTS BUDGETED FOR SAN MIGUEL COUNTY, COLORADO

WHEREAS, a public hearing was held on December 16, 2011, before the San Miguel County Board of Commissioners, San Miguel County, Colorado to accept public comment, and

WHEREAS, the need exists to appropriate additional expenditures for use by various county funds and spending agencies, as follows:

Social Services Fund \$ 190,000

Conservation Trust Fund \$ 30,886

AND, WHEREAS, Funds available to be appropriated for the above purposes include:

AND, WHEREAS, appropriate public notice of this action has been made as required by section 29-1-106 and 109, C.R.S.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of San Miguel County, Colorado, for the purposes detailed above:

THAT, the 2011 appropriation for the San Miguel County Social Services Fund is hereby increased from \$1,216,281 to \$1,406,281;

AND THAT, the 2011 appropriation for the San Miguel County Conservation Trust Fund is hereby increased from \$0 to \$30,886;

AND, THAT the supplemental appropriations detailed above increase the total appropriations for San Miguel County for 2011 from \$20,043,374 to \$20,264,260.
