The two victims of the plane crash have been identified as Costas John Sivyllis, 30, and his wife of four days, Lindsey Vogelaar, 33, both of Port Orange, Florida. The two had eloped to Telluride for a small wedding (held Oct. 1) and adventure-filled honeymoon that they were documenting online for their friends and families to follow. Both worked in the airline industry; he was a United Airlines pilot and a flight instructor. The privately owned Beechcraft Bonanza aircraft was found crashed in Ingram Basin east of Telluride yesterday afternoon. It departed the Telluride Airport (TEX) at approximately 1245pm and is believed to have crashed as soon as 10-15 minutes later. The couple was heading back to Florida with a possible stop in Oklahoma to refuel. The NTSB is handling the investigation.
